

If the result of the search shows no registered owner for the route in question, please send us a copy of the Land Registry's response and we will advise you how to proceed.

Once we have received a properly completed application, it will be added to the list of those awaiting investigation, the 'claims list'. You can view the 'claims list' on our web site at [www.hants.gov.uk/row](http://www.hants.gov.uk/row). The list can be found under 'changing rights of way' and is updated monthly.
